PART II

NARRATIVE SUMMARY

During the first six months of 1980 the trends established during the last half of 1979 continued. Although there was much work to be done with the limited number of Aircrews on hand, the "Tomcats" continued the high standards set by their predecessors.

In January the "Tomcats" participated in VMA-214's Marine Corps Combat Readiness Evaluation System (MCCRES) evaluation, and worked co-ordinated F-4/F-15 defensive tactics (DEFTAC) exercises at NAS Miramar. A climax was reached at the end of the month with "Operation Canyon Creek". This combined 40-aircraft strike entailed an 1100 NM strike into the Hill AFB Utah Test Training Range (UTTR) in a complex Deep Air Support (DAS) scenario.

During February the Squadron met with USAF F-15's at Fairchild AFB and F-16's at Hill AFB in DEFTAC exercises. A successful Shrike shoot at China Lake and providing support for VMFA-112's deployment at MCAS Yuma rounded out this eventful month.

March proved a strong test for the Squadron. VMA-311 was tasked with supporting Gallant Eagle 80; the only A-4 attack squadron in the massive ten-day coordinated Air Force and Army exercise at Fort Irwin. The 7501 MOS training of one pilot was completed. The Squadron was very busy in preparation for re-certification as a nuclear-capable squadron, and the "Tomcats" did exceptionally well in the culmination of this training in the Nuclear Weapons Acceptance Inspection (NWAI) on 24 March. In addition to preparing for the NWAI, a five-plane Air Combat Tactics Instructor (ACTI) detachment was sent to MCAS Yuma during this period. The remainder of the month found VMA-311 receiving a Naval Safety Center Safety Survey, firing a live AGM-45 Shrike, supporting VMA-214's "Operation Pinnacle Peak", and participating with Air National Guard A-7's in DEFTAC maneuvers at Kirtland AFB.

Although anticipating a rather quiet month in April, the "Tomcats" kept up a high operational pace. The 7501 MOS training of two pilots was completed. April also found VMA-311 participating in North American Air Defense Command (NORAD) exercises, a MAG-13 bombing COMPEX, Amphibious Landing Exercise (PHIBLEX) 1-80, and DEFTAC with Canadian F-5's. Warm-up smoke missions were also being conducted for the upcoming Combined Arms Exercises (CAX) in May.

During the first weeks of May, VMA-311 provided support for CAX's 4-80 and 5-80. The missions were primarily the delivery of smoke, with some live ordnance sorties. A special operations exercise at Nellis AFB and DEFTAC exercises with USAF F-15's at Luke AFB followed shortly thereafter.

On May 26 the Squadron left for MCAS Yuma for its first deployment in 1980. With limited ranges where delivery of high explosive ordnance could be utilized, the "Tomcats" ran many creative missions utilizing practice ordnance in combination with support from other squadrons.

In the first week of June, while still on the Yuma deployment, the Squadron underwent a MCCRES evaluation with outstanding results. After returning from Yuma, chemical spray tank evaluation missions continued at the US Army Dugway Proving Grounds in Utah. June 13 saw a change of command, as LtCol M. F. WILLIAMSON relieved LtCol T. L. HAMPTON. One week later, a Wing Administration and Maintenance (A&M) Inspection took place, and the "Tomcats" did quite well despite the shortage of personnel on hand.

Over the reporting period VMA-311 conducted extensive electronic warfare training in the Echo Range at China Lake. With the mini-strikes conducted in the type environment the Squadron is anticipating, the training was excellent.

Overall from 1 January to 30 June 1980, VMA-311 flew 2330.1 hours and 1478 sorties. VMA-311 has flown 11,011.8 accident-free hours covering a 27 month period.
