#### PART II

#### NARRATIVE SUMMARY

The second half of 1981 saw the "Tomcats" achieve new standards of excellence in readiness and safety. Despite a significant increase in the number of new pilots on board, the quality of training and tactical proficiency excelled throughout the six month period.

The month of July was busy for the "Tomcats" with the squadron flying 528.1 hours, exceeding the monthly projection by 78.1 hours. Support varied from contained CAS missions with VMA(AW)-242 to TPQ missions with MASS-3, both at Camp Pendleton. Training played a key role during the month with three pilots completing ACTI training, one attending the WTI syllabus at MCAS Yuma, and two replacement pilots from VMAT-102 receiving 8 training sorties. Highpoint of the month was the extremely successful DEFTAC/deployment to Luke AFB, Arizona for training with the F-15's. A mutual appreciation for the capabilities of both aircraft was gained by all participants. Back at El Toro, practice nuclear loads were conducted in preparation for the squadron NTPI scheduled for August.

For the third consecutive month, August saw the squadron break the 500 hour mark. During this month the "Tomcats" completed an NTPI, a squadron COMPEX and DAS strikes to NAS Fallon, Nevada, and the NWC China Lake complex in California. The latter involved working with a USAF AWACS aircraft. Additionally, two replacement pilots from VMAT-102 received 12 training sorties at El Toro. Returning from Yuma, Captain D. A. JARSTAD became the latest "Tomcat" WTI. Various support missions at Camp Pendleton, Chocolate Mountains and Twentynine Palms rounded out the month for a total of 539.4 hours.

A milestone was reached in September when the squadron accumulated the highest monthly flight hour total for the year with 553.6 hours. Diversity characterized the nature of the missions flown, from simulated smoke missions at Camp Pendleton to a mock attack on the USS ENGLAND with VMFA-531's "Ghost Flag" exercise. At Nellis AFB the "Tomcats" helped kick off the first EWCAS record trials with 2 pilots, 12 maintenance personnel and 5 Skyhawks. The deployment was to explore the effectivness of current doctrine in the modern electronic battlefield. The squadron flew support for LFTCPAC at Twentynine Palms and ended up the month conducting two live Shrike firings and a DAS strike to NAS Fallon.

The high tempo of operations continued into October with another month of over 500 hours flown. The pilots at EWCAS returned with valuable lessons to pass on to their fellow "Tomcats". The 189.9 hours flown on the 5 Nellis aircraft in less than a month was indicative of the high pace of operations during this period. At El Toro a similar pace saw the squadron launch a 33 plane inter-service strike to NAS Fallon, named Tripoli Thunder. Participation in the Kernel Usher PHIBLEX at Camp Pendleton and LFTCPAC CAS missions at Twentynine Palms wrapped up the highlights for the month of October.

The majority of the squadron's effort in November was devoted to the 12 plane 2 week deployment to NAS Fallon, Nevada. Twenty-five squadron pilots flew 333.8 hours completing 399 syllabus X's. New pilots to the squadron benefited greatly from the variety of sorties flown, from CAS, DAS and air refueling to DEFTAC, LATT and raked range bombing. Unique to the deployment was the inclusion of an 81mm mortar section from 2d Battalion, 9th Marines accompanying a ground FAC from VMFA-314. Additional support included New Mexico Air National Guard A-7's, USAF A-10's, a Navy KA-3 and Marine Corps OA-4M's, F-4's, KC-130's and reserve A-4's. The deployment was quite successful and provided invaluable training for all concerned.

Local flying dominated the month of December with CAS, spray and TPQ missions flown at Twentynine Palms and Camp Pendleton. The number of pilots on board had increased to twenty-seven, by the end of the year.

## Personnel and Administration

The squadron experienced an increase in personnel over the past few months especially in the number of aviators on board. Wise use of the available assets will be mandatory if the overall proficiency of the squadron is to be maintained.

# LOGISTICS/SUPPLY

The second half of 1981 was characterized by a fast tempo of operations which the logistics department handled with a minimum of personnel and a high turnover rate. Major events were the Luke AFB deployment in July and the NAS Fallon deployment in November. Additionally, in mid October the logistics department planned and executed the administrative move of all essential squadron equipment to the VMGR-352 hangar to facilitate the painting of the squadron hangar deck.

#### TRAINING

Training continued to be an important facet of this command's activity. The squadron normally scheduled a half day of training per week and also a standdown every other month with a full day devoted to safety training. The EST was administered on 19 October and a PFT on 4 December. Ninty-two percent of squadron personnel had gas chamber training in December and squadron personnel completed 28 MCI courses during the preceeding six months.

# CIVIC ACTION

During November, the squadron enthusiastically took part in the Combined Federal Campaign and under the leadership of 1st Lieutenant PEELER had 100% participation. Furthermore, 1st Lieutenant PEELER and Sgt ACKERMAN painted a forty foot reproduction of the squadron insignia on the roof of the "Tomcat" hangar.
