#### SECTION II

#### NARRATIVE SUMMARY

#### Command, Operations and Training

The second half of the calendar year began with a rebuilding maintenance effort for VMA-311 Tomcats. The Squadron very successfully participated in Gallant Eagle in September. Closing out the year the Tomcats had a prosperous deployment to MCAS Yuma.

In September VMA-311 detached six aircraft and ten pilots, with appropriate maintenance personnel, to EAF Twentynine Palms. The Tomcats supported the Gallant Eagle combined services exercise with close air support and other tactical missions. While at Gallant Eagle the Squadron qualified two Low Altitude Tactics Instructors CAPT HAYNES and CAPT SULLIVAN, also training recently joined Lieutenants toward a 7501 MOS.

The maintenance department was given an Administrative and Maintenance Inspection by the Wing in October. Noteworthy from the inspection was Avionics receiving an outstanding and an outstanding grade given to the Tomcats for FOD prevention. The Squadron continued a fairly high paced tempo of operations during this period while supporting the Weapons and Tactics Instructors course with two aircraft.

Special Weapons Qualifications were earned by three members of the Tomcats CAPT ROSE, CAPT SULLIVAN, and CAPT HAYNES during November. This month also had VMA-311 preparing for a deployment to MCAS Yuma.

The Squadron deployed to MCAS Yuma for two weeks on 7 December, and had an outstanding deployment. Despite some of the worst weather the desert southwest has seen in decades the Tomcats flew two hundred and forty-two sorties for almost three hundred and forty-nine flight hours. The Tomcats flew missions ranging from day and night close air support to dissimiliar air combat and helicopter escort and evasive maneuvering. The Squadron's Combat Readiness Percentage increased by .9% during the deployment. Squadron pilot qualifications also showed a gain in MCAS Yuma with MAJ BRANNON, CAPT ROSE and CAPT HAYNES becoming Air Combat Tactics Instructors and FIRST LIEUTENANT's SPERLING and BALL attaining their 7501 MOS. The Maintenance Department gave an outstanding effort with thirteen of the Squadron's fourteen aircraft up and flying.

#### Personnel and Administration

The personnel strength of the Squadron remained stable throughout the period, with about as many people leaving as joining. As is prevalent in many other aviation units, a lack of experienced Staff NCO's continued to be a problem. The Administration Department was inspected by the Marine Corps Disbursing on Site Examination Team in November, and received a grade of 16% error rate, which is outstanding when compared with the Wing average of 24%.

#### 1. General.

a. <u>Purpose</u>: This Annex establishes standard procedures, responsibilities and policies for guidance of VMA-311 in the area of personnel administration during the deployment to MCAGCC, Twenty-Nine Palms, California.

#### b. Personnel Support Procedures.

- (1) SRB/OQR's will not be taken to Twenty-Nine Palms.
- (2) All normal administrative business will be handled by the Squadron Administration Section in the rear.
  - (3) A personnel roster is contained in Appendix 1.

#### 2. Discipline, Law and Order.

- a. All existing regulations pertaining to law, order and discipline remain in effect.
- b. Court-martial and Non-Judicial punishment will be delayed until the squadron returns to MCAS El Toro.

#### 3. Leave.

a. Leave is not authorized for deploying personnel except for emergencies. Emergency leave will be processed through the Squadron Administration Department.

#### 4. Postal.

- a. Deploying personnel will continue to use the El Toro mailing address.
- b. Mail will be delivered to Twenty-Nine Palms when transportation is available.

### 5. <u>Pay</u>.

- a. Paychecks will be available on paydays give or take a day to allow for transportation from El Toro. For those Marines who wish to leave their checks at El Toro and have someone pick up, S-1 will require a hand written statement that names the individual who is authorized to pick up the check.
- b. Sergeants and below with comrats will pay for meals. Sergeants and below with a meal card will use meal cards. NCOIC's will ensure that there are no missed

meals. All SNCO's and Officers will be required to pay for their meals while deployed.

c. Banking facilities are available at Twenty-Nine Palms, but limited.

#### 6. Liberty

- a. Liberty will be controlled by the Department Heads, but only when specifically authorized by the Commanding Officer.
- b. Liberty limits are no further than mainside at Twenty-Nine Palms. Off base liberty is not authorized.

#### 7. Base Facilities

a. Hours of operation for base facilities will be posted in the working spaces and billeting areas.

#### 8. Uniform

- a. Coveralls will not be worn outside of work spaces. Utilities are required for the messhall.
- b. The wearing of flight clothing is restricted to the vicinity of aircraft lines, maintenance, and operations buildings. Pilots are authorized to wear flight clothing at Camp Wilson in performance of their normal duties, and in the messhall. Utilities must be worn if going to mainside.
- c. The working uniform will be flight clothing, utilities, coveralls and field jackets as appropriate. Utility covers will be worn at all times, except in designated areas (i.e. the flight line).
  - d. Civilian clothes are not authorized in Camp Wilson.
- 7. Privately Owned Vehicles. POV's are not authorized.

#### 3. Execution.

- a. The advance maintenance echelon will deploy via KC-130 to Twenty-Nine Palms EAF on or about 1445, 01 September 1984.
  - b. The Fly-out of 6 A-4M aircraft will be at 1200, 03 September 1984.
- c. The main maintenance echelon will deploy via KC-130 to Twenty-Nine Palms EAF on or about 0245, 02 September 1984.
- d. All maintenance department personnel will deploy, less those required for check, test, repair and inspection of aircraft remaining at MCAS El Toro, and those with formalized education programs. Personnel rosters for advance, main and rear echelons will be promulgated by separate correspondence.
- e. Squadron pack-up will be completed by 30 August 1984, with the exception of those items necessary for the launch on 03 September 1984.
- f. A supply pack-up of pool and non-pool items will be drawn from supporting units and augmented as available from squadron assets. The supply pack-up will be staged as directed by the Embarkation Officer.
- g. I-Level Ground Support Equipment will be provided by the ACE at Twenty-Nime Palms. O-level GSE will be provided by VMA-311.
- h. Tool room will embark the common tools, special tools and test equipment not held by individual work centers along with 40 pair of safety goggles. Work center supervisors will advise the tool room of anticipated requirements for both the deployed and rear echelons. Tool room will include in it's pack-up VHF-FM Hand Transceivers, for use by Maintenance Control, Flight Line, Ordnance and Airframes Division.
- i. Ordnance will be drawn and handled in accordance with squadron and ACE operating procedures.
  - j. Ordnance support equipment and vehicles will be provided by ACE.
- k. Airframes division will ensure as many canopy covers as available to protect canopies from any sand damage, and that spare tailhooks are included in the pack-up.
  - 1. Line division will ensure that sufficient consumables are in the

pack-up, to include tires, oil, and hydraulic fluids, along with all red gear for the aircraft. Additionally, Line Division will coordinate with tool room to ensure that protective goggles are provided for line crews.

#### 1. Supply

- a. General. To provide and establish policies for logistical support for VMA-311 at the Expeditionary Air Field (EAF), MCAGCC, Twenty-Nine Palms, California.
- b. Embarked Supplies. The Embarkation Officer will take delivery of all squadron cargo arriving by military airlift. Coordination for the use of forklifts and operators will be accomplished throught the ACE Logistics Officer.

#### c. Control and Distribution of Material and Supplies.

- (1) Each department and work center will embark sufficient administrative supplies to support deployed operations for twenty-one (21) days.
- (2) All requisitions for aviation material and supplies will be submitted to the squadron expeditor.
- d. Resupply. The resupply of aviation materials while deployed will be limited. All requisitions will be passed through the squadron expeditor.
- e. Refueling. JP-5 issued through the TAFDS will initially be purchased with a DD-186 Form (Jet Fuel Identiplate). Upon approval from the ACE Supply Officer, a running tally sheet for daily fuel purchases will be utilized. Diesel and mogas will be issued from refuelers as required.
- (1) The squadron will embark enough POL supplies (oil, hyd fld, etc.) for the duration of the deployment.

#### 2. Medical.

- a. The health and dental records will remain with each detachment's parent unit and will not be taken to the field.
- b. Routine military sick call will be from 0730-0930 and 1300-1430. Emergencies will be treated at any time.
- c. Routine dental service will not be available during the exercise. Emergenicies will be treated as required at the mainside dental facility, MCAGCC, Twnety-Nine Plams.

#### 3. Mobility/Transportation.

a. The squadron is taking (1) M35 and (2) M151's for motor transport support.

#### 4. Billeting.

a. All squadron personnel will be quartered in tents at Camp Wilson. Tent assignments will be issued on arrival at MCAGCC, Twenty-Nine Palms. Tent repair should be passed to the Squadron Logistics Officer.

#### 1. Organization and Embarkation.
